MINUTES OF THE BOARD MEETING

July 29, 2024

10:00 AM

Board Chair Ms. Kathy Linden called the meeting to order at 10:00 am and presided over the meeting.

The invocation was given by Ms. Misty Garrison and the roll call was taken by Ms. Linden. The Board Members present were Ms. Misty Garrison, Mr. Daniel Powers, and Ms. Kathy Linden. Board members absent were Mr. General Jackson and Ms. Michelle Callahan-Alvis. A quorum of the Board Members was present. Ms. Jeannie Price, Executive Director, and Ms. Neva Conway, legal counsel were present. Other office staff members present were Stacey Little and Matthew Higgins. There were public visitors present also.

Ms. Linden asked if the Board Members had received and read the agenda for July 29, 2024. All members present confirmed they had and with all ayes, the agenda was adopted.

Ms. Linden asked if the Board Members present had received and read the minutes from the April 29, 2024, Board Meeting. All members present confirmed they had. Mr. Powers made a motion to adopt the minutes, Ms. Garrison seconded, and with all ayes, the motion was carried.

There were no hearings held during this period.

Ms. Hinton stated she was excited to open a school for Natural Hair and Cosmetology and would be opening on August 1st. After a brief discussion, Ms. Garrison made a motion to approve the new school application, Mr. Powers seconded with all ayes, the motion carried.

Ms. Linden invited Sonya Hildreth to speak to the Board regarding her new school application for East Alabama School of Esthetics. Ms. Hildreth stated she was excited to open an esthetics school in Auburn and will be opening on August 19th. After a brief discussion, Mr. Powers made a motion to approve the new school application, Ms. Garrison seconded with all ayes, the motion carried.

Ms. Price discussed the proposed administrative rule changes for Apprentices. Ms. Price stated after the proposed rule changes were submitted, there would be a 35-day public comment period. Any comments received would be presented to the board at the 10/21/2024 board meeting. After a brief discussion, Ms. Garrison made a motion to approve the new rule changes, Mr. Daniel Powers seconded with all ayes, the motion carried.

Ms. Linden asked if there was any other business to be addressed. With no other business, Ms. Garrison made a motion to adjourn the meeting and with all ayes, the meeting was adjourned at 10:22 am.
